Product

Product description:

Protecta FR Graphite Plate is a preformed self-adhesive intumescent plate, used to reinstate the fire resistance performance of flexible wall constructions when punctured with plastic wall boxes. It is used where the walls have been provided with apertures for the penetration of conduits and cables into socket boxes, on one or both sides of the wall.

The graphite plate immediately reacts to fire through the heat and automatically expands and fills up the box, preventing fire from passing through.

Fitting FR Graphite Plate will reinstate the fire resistance performance of flexible wall constructions for up to 120 minutes. It also prevents the passage of fire through the electrical conduits between socket boxes.

Cut-off criteria:

All major raw materials and all the essential energy is included. The production processes for raw materials and energy flows with very small amounts (less than 1%) are not included. These cut-off criteria do not apply for hazardous materials and substances.

Allocation:

The allocation is made in accordance with the provisions of EN 15804. Incoming energy and water and waste production in-house is allocated equally among all products through mass allocation. Effects of primary production of recycled materials is allocated to the main product in which the material was used. The recycling process and transportation of the material is allocated to this analysis.

Data quality:

Specific data for the product composition are provided by the manufacturer. The data represent the production of the declared product and were collected for EPD development in the year of study. Background data is based on EPDs according to EN 15804 and different LCA databases. The data quality of the raw materials in A1 is presented in the table below.


